

PREMIER LICENSE AGREEMENT

SAGE PUBLICATIONS, INC.

AND

The University of Texas System

AND

The Houston Academy of Medicine

This License Agreement (the "Agreement") is effective as of January 1, 2017 (the "Effective Date") and is entered into by and between SAGE Publications, Inc., a Delaware Corporation, located at 2455 Teller Road, Thousand Oaks, California ("SAGE"), with a federal tax ID number of 95-2454902 and The University of Texas System, a non-profit academic institution with its principal offices located at 601 Colorado Street, Austin, TX 78701 (University or UT System or UTS) and the Houston Academy of Medicine, a non-profit corporation with its principal offices at 1515 Herman Drive, Houston TX 77004-71276 (HAM). University and HAM are collectively referred to herein as the "Licensees" or individually as the "Licensee". Every instance of "Licensee" is understood to be "each Licensee" unless specifically noted otherwise. SAGE and Licensees collectively referred to herein as the "Parties".

In consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

I. DEFINITIONS

The following terms shall have the following meanings:

"Authorized Users" shall mean individuals who are authorized by the Licensees (which shall include those individuals authorized by the Institutions hereunder) to access the Licensees' information services whether on-site or off-site via Secure Authentication and who are affiliated to the Licensees as a current student (undergraduates and postgraduates), employee (whether on a permanent or temporary basis), alumnus, faculty member (including temporary or exchange researchers for the duration of their assignment), researcher (including temporary or exchange researchers for the durations of their assignment), independent contractor acting as faculty or staff member, executive officer, or member of the governing boards of the University of Texas System, UT System Institutions, the Houston Academic or Medicine, or the HAM Institutions, as specified or contractor of the Licensees. Persons who are not a current student, member of staff or a contractor of the Licensee, but who are permitted to access the Licensees' information services from computer terminals within the physical premises of a Licensee ["Walk-In Users"] are also deemed to be Authorized Users, only for the time they are within the physical premises of the Licensee. Walk-In Users may not be given means to access the Licensed Material when they are not within the physical premises of a Licensee.

"Commercial Use" shall mean use for the purpose of monetary reward (whether by or for the Licensees or an Authorized User) by means of the sale, resale, loan, transfer, hire or other form of exploitation of the Licensed Work. For the avoidance of doubt, neither recovery of direct cost by the Licensees from Authorized Users, nor use by the Licensees or Authorized Users of the Licensed Materials in the course of research funded by a commercial organization is deemed to constitute Commercial Use. Authorized Users may engage in all the Authorized Uses listed in Section V. of this agreement as this behavior does not constitute Commercial Use.

"Educational Purposes" shall mean for the purpose of education, teaching, distance learning, private study and/or research.

"Fees" shall mean the fees as set out in Exhibit 3.

"Institutions" shall mean the participating Institutions identified on Exhibit 2 attached hereto and incorporated herein by reference. The "UT System Institutions" are identified in Section A of that Exhibit 2, and the "HAM Institutions" are identified in Section B of that Exhibit 2.

"Intellectual Property Rights" shall mean patents, trademarks, trade names, design rights, copyright (including rights in computer software and moral rights), database rights, rights in know-how and other intellectual property rights, in each case whether registered or unregistered and including applications for the grant of any of the foregoing and all rights or forms of protection having equivalent or similar effect to any of the foregoing which may subsist anywhere in the world.

"License" shall mean the non-exclusive, non-transferable license to access and use the Licensed Material and all updates related thereto via Sage Journals Online ("SJO"), SAGE's online delivery platform.

"Licensed Materials" shall mean the materials that are subject to this Agreement and shall consist solely of the titles published by SAGE as set forth on Exhibit 1 attached hereto and incorporated herein by reference.

"Reasonable Amount" shall mean not more than 10% of the content contained in the Licensed Materials.

"Secure Authentication" shall mean access to the Licensed Material by Internet Protocol ("IP") ranges or by another means of authentication agreed between the SAGE and Institution from time to time.

II. GRANT OF LICENSE

SAGE hereby grants to each Licensee on its own behalf a License to access and use the Licensed Materials and all updates thereto via SJO in a manner consistent with the Agreement. Should SAGE lose the right to license any of the content comprising the

Licensed Materials during the term of the Agreement, SAGE shall, at its sole discretion and as business needs dictate, replace the content with similar content. SAGE shall give written notice to the Licensees of such withdrawal no later than 30 days following the removal of any item pursuant to this section. If any such withdrawal renders SJO less useful to Licensees or its Authorized Users, SAGE shall reimburse Licensees in an amount that the withdrawal is proportional to the total Fees owned by Licensees under this Agreement.

The *SAGE Premier All Access Model* offers participating members access to all SAGE journal titles that are part of the SAGE Premier offer, including all titles which are added to the published SAGE Premier list (new titles added in January of each year) for the duration (term) of the agreement (3 years). Titles which cease to be published by SAGE during the term of this Agreement shall cease to be included in the list of titles included in the *SAGE Premier All Access Model* from the time at which they cease to be published by SAGE. The Licensees will be required to maintain, at SAGE's list price, their single subscriptions of titles transferring from other publishers to SAGE during the term of the agreement where the Participating Institution held a bona fide subscription with the former publisher in the year preceding the transfer.

Notwithstanding anything herein to the contrary, in the event that SAGE loses the right to license any of the content comprising the Licensed Materials during the term of this Agreement in an amount that equates to 5% or more of the total net number of titles initially included in the Licensed Materials under this Agreement, SAGE will provide Licensees with a pro-rata adjustment to the pricing reflected herein in an amount that will reflect the reduction of the net adjusted number of titles that remain in the content comprising the Licensed Materials compared with the net number of titles initially included in the Licensed Materials under this Agreement.

Online access to journal content includes ownership of the Licensed Materials published by SAGE during the term of the Agreement. SAGE will provide each Licensee with complimentary access to all the content of titles set forth in the Licensed Materials starting in 1999 through the current day while this Agreement is in place between SAGE and that Licensee.

This License extends to the Institution's Authorized Users. The Licensed Materials may be networked throughout the geographic areas of each Institution and may also be made available remotely through secure access procedures that each Institution establishes.

III. PROPRIETARY RIGHTS IN THE LICENSED MATERIALS

On its own behalf and on behalf of the Institutions and Authorized Users, Licensee acknowledges and agrees that (i) the Licensed Materials are proprietary to SAGE, (ii) the Licensed Materials shall remain the exclusive property of SAGE, and (iii) the Licensees, the Institutions and the Authorized Users have no rights in or to the Licensed Materials other than as set forth herein. The Licensed Materials are copyrighted by SAGE or third Parties designated in individual journals and all rights are reserved by SAGE. Neither Licensees nor the Institutions shall duplicate, distribute, sell, commercially exploit, create

derivative works from, or otherwise make available the Licensed Materials or information contained therein, in any form or medium, to any third party. Each Licensee will exercise reasonable, good faith efforts to inform its Authorized Users of the restrictions on use of the Licensed Materials and to enforce such restrictions; however, the Licensees shall not be liable for the actions of individual users who act without the knowledge or consent of the Licensees.

IV. FEES

SAGE shall invoice the Licensees for the Licensed Materials as noted in Exhibit 3.

All fees are due and payable by each Licensee thirty (30) days after the date of invoice.

V. AUTHORIZED USE OF LICENSED MATERIALS

Licensees, the Institutions and Authorized Users may use the Licensed Materials for purposes of research, education or other non-commercial use as follows:

Analysis. Authorized Users shall be permitted to extract or use information contained in the Licensed Materials for educational, scientific, or research purposes, including but not limited to extraction and manipulation of information for the purposes of illustration, explanation, example, comment, criticism, teaching, research, or analysis.

Course Packs. Licensees, the Institutions and Authorized Users may use a Reasonable Amount of the Licensed Materials in the preparation of Course Packs or other educational materials.

Digitally Copy. Licensees, the Institutions and Authorized Users may download and digitally copy a Reasonable Amount of the Licensed Materials.

Display. Licensees, the Institutions and Authorized Users shall have the right to electronically display the Licensed Materials.

Electronic Reserve. Licensees, the Institutions and Authorized Users may use a Reasonable Amount of the Licensed Materials for use in connection with specific courses of instruction offered by Licensee.

Inter-Library Loan ("ILL"). The Institutions shall be permitted to use Reasonable Amounts of the Licensed Materials to fulfill occasional requests from other, non-participating institutions, a practice commonly called Inter-Library Loan. The Licensees agree to fulfill such requests in compliance with Section 108 of the United States Copyright Law (17 USC §108, "Limitations on exclusive rights: Reproduction by libraries and archives") and the Guidelines for the Proviso of Subsection 108(2g)(2) prepared by the National Commission on New Technological Uses of Copyrighted Works (CONTU).

The electronic form of the Licensed Materials may be used as a source for ILL. Secure

electronic transmission as used by Ariel or Prospero to fulfill ILL requests is permitted. Participating Libraries agree that copyright notices will be sent on all ILL transmissions

Print Copy. Licensees, the Institutions and Authorized Users may print a Reasonable Amount of the Licensed Materials.

Recover Copying Costs. Licensees and the Institutions may charge a reasonable fee to cover costs of copying or printing portions of Licensed Materials for Authorized Users.

Scholarly Sharing. Authorized Users may transmit to a third party colleague in hard copy or electronically, minimal, insubstantial amounts of the Licensed Materials for personal use or scholarly, educational, or scientific research or professional use but in no case for resale or commercial purposes. In addition, Authorized Users have the right to use, with appropriate credit, figures, tables and brief excerpts from the Licensed Materials in the Authorized User's own scientific, scholarly and educational works.

Text Mining. Authorized Users may use the licensed material to perform and engage in text mining /data mining activities for legitimate academic research and other educational purposes. Those uses beyond educational use shall require SAGE's permission.

VI. RESTRICTIONS

Except as provided herein, the Licensees and Authorized Users shall not use the Licensed Materials as follows:

Alter Identification. Remove, obscure or modify copyright notices, text acknowledging, attributions or other means of identification or disclaimers as they appear in the Licensed Materials;

Alter Licensed Materials. Alter, adapt or modify the Licensed Material, except to the extent necessary to make the Licensed Materials perceptible on a computer screen, or as otherwise permitted in this Agreement. Alteration of words or their order is strictly prohibited.

Commercial Use. Sell or resell the Licensed Material unless the Licensees or an Authorized User has been granted prior written consent by the Publisher. Use all or any part of the Licensed Materials for any Commercial Use or for any purpose other than Educational Purposes;

Distribution. Display or distribute any part of the Licensed Material on any electronic network, including without limitation the Internet and the World Wide Web, and any other distribution medium now in existence or hereinafter created, other than by a Secure Authentication;

This Clause shall survive termination of this Agreement for any reason.

VII. CONFIDENTIALITY

To the extent authorized by the Constitution and the laws of the State of Texas, and subject to the Texas Public Information Act, Licensees agrees that, except with the prior written consent of SAGE, or as required by law or compelled by legal process including any applicable state open record laws, it may only disclose the terms of this Agreement to the Institutions.

Notwithstanding anything herein to the contrary, in no event shall SAGE disclose to anyone other than the Licensees any of the access codes, passwords, or any other access information provided to the Licensees by SAGE to enable the Licensees to access and use the Licensed Materials, and the Licensees hereby agrees to treat all such information as strictly confidential at all times.

VIII. NO WARRANTIES

SAGE IS PROVIDING THE LICENSED MATERIALS IN AN "AS IS" CONDITION. SAGE DOES NOT WARRANT, GUARANTEE, OR MAKE ANY REPRESENTATION REGARDING THE ACCURACY, COMPLETENESS, CORRECTNESS, RELIABILITY, CURRENCY OR OTHERWISE, OF ANY PORTION OF THE LICENSED MATERIALS OR THE USE OR RESULTS TO BE OBTAINED FROM USING THE LICENSED MATERIALS OR THE INFORMATION CONTAINED THEREIN, OR ANY RELATED DOCUMENTATION OR WRITTEN MATERIALS. SAGE DOES NOT MAKE ANY REPRESENTATIONS OR WARRANTIES WHATSOEVER, EXPRESS OR IMPLIED, WITH RESPECT TO THE LICENSED MATERIALS AND, IN PARTICULAR, SAGE DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY, ACCURACY, NONINTERFERENCE, NONINFRINGEMENT, INFORMATIONAL CONTENT, OR FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THE LICENSED MATERIALS.

IX. LIMITATION OF LIABILITY

NEITHER SAGE NOR EITHER LICENSEE SHALL NOT BE LIABLE FOR ANY LOSS OR DAMAGE, INCLUDING LOST PROFITS, LOSS OF USE, OR INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR EXEMPLARY DAMAGES, CAUSED TO ANY PERSON AS A RESULT OF THIS AGREEMENT. THE USE OF THE LICENSED MATERIALS OR THE INFORMATION CONTAINED THEREIN REGARDLESS OF WHETHER THE POSSIBILITY OF SUCH DAMAGES WAS FORSEEABLE. WITHOUT LIMITING THE FOREGOING, THE AGGREGATE LIABILITY OF SAGE TO EACH LICENSEE AND OF EACH LICENSEE TO SAGE, IF ANY, SHALL BE LIMITED TO THE SUBSCRIPTION PRICE PAID BY THE LICENSEE FOR THE LICENSED MATERIALS WITHIN THE TWELVE MONTH PERIOD PRECEDING A PARTY'S ASSERTION OF THE OTHER PARTY'S LIABILITY.

SAGE will defend, indemnify and hold the Licensees harmless from any action based on a claim that Licensees' use of the SJO in accordance with this Agreement infringes any patent, copyright, or trade secrets of any third party. The limitations on SAGE's liability set forth in this Agreement do not apply to the preceding sentence.

X. ACCESS AND USE

Licensees, the Institutions and Authorized Users shall have unlimited access to the Licensed Materials, 24 hours/day, seven days/week. Notwithstanding the foregoing, SAGE reserves the right to shut down SJO without prior notice to resolve any technical issues that may arise at any time as determined in SAGE's sole and absolute discretion.

XI. SYSTEM REQUIREMENTS

Licensees acknowledges that there are certain system requirements that are necessary in order to use SJO, and Licensees and the Institutions are financially and technically responsible for ensuring that these requirements are met. These system requirements are: (a) full access to the Internet (TCPIP) and (b) a World Wide Web browser. SAGE recommends using the most current browsers available.

XII. FORCE MAJEURE

Neither the Licensees nor SAGE shall be responsible for any failure to perform, or delay in performance, in whole or in part, due to unforeseen circumstances or circumstances beyond its control.

XIII. TERM AND TERMINATION

This Agreement shall be in effect from January 1, 2017 through December 31, 2019 (the "Term").

SAGE may cancel this License with respect to a Licensee if that Licensee materially violates any of the terms and conditions set forth herein, including the Confidentiality provision in Section (VI) and SAGE has provided the Licensee with thirty (30) days' written notice of cancellation setting forth the material violation; provided that the material violation is not caused by SAGE. The cancellation will not be effective if the material violation is fully cured by the Licensee prior to the end of the thirty-day (30-day) period. Provided, however, such cancellation shall not affect the Agreement or License between SAGE and other Licensee. Thirty (30) days prior to the expiration of the Term, and upon a Licensee's written request, SAGE shall deliver to each Licensee the data comprising the content from 2016 of the Licensed Materials, and the use of such provided material shall be governed by the terms of this License. All information will be delivered in an electronic medium agreed to by the Parties. Any Licensee that has had this License cancelled with respect to that Licensee due to that Licensee's violation of any of the terms set forth herein shall not be entitled to access the Licensed Materials or any portion thereof after such cancellation. A Licensee may terminate this Agreement

with respect to that Licensee if SAGE materially violates any of the terms and conditions set forth herein, including the Confidentiality provision in Section (VI) and that Licensee has provided SAGE with thirty (30) days' written notice of termination setting forth the material violation; provided that the material violation is not caused by that Licensee. The termination will not be effective if the material violation is fully cured by SAGE prior to the end of the thirty-day (30-day) period. Provided, however, such termination shall not affect the Agreement or License between SAGE and the other Licensee. The terms and conditions of paragraphs II, V, VI, and X and of the attached Addendum to the Agreement shall survive termination of this License or of the Agreement.

XIV. GOVERNING LAW

This Agreement shall be construed under, and the performance governed by, the laws of the State of Texas without regard to principals governing conflict of laws.

Each party consents to, and waives any right to object to, jurisdiction with respect to the resolution of disputes hereunder in Travis County, Texas. In any legal action or other proceedings between the Parties, to the extent authorized by the laws and Constitution of the State of Texas, the prevailing party shall be entitled to recover from the non-prevailing party all reasonable costs and expenses incurred in such action or proceeding, including, without limitation, reasonable attorneys' fees and costs. Notwithstanding the foregoing, the Parties specifically reserve the right to seek provisional remedies or injunctive relief or other equitable remedy in a court of competent jurisdiction to the extent authorized by applicable law.

XV. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement of the Parties and supersedes all prior communications, understandings and agreements relating to the subject matter hereof, whether oral or written.

XVI. AMENDMENT

No modification or claimed waiver of any provision of this Agreement shall be valid except by written amendment signed by authorized representatives of all the Parties hereto.

XVII. SEVERABILITY

If any provision or provisions of this Agreement shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

XVIII. WAIVER

Waiver of any provision herein shall not be deemed a waiver of any other provision herein, nor shall waiver of any breach of this Agreement be construed as a continuing waiver of other breaches of the same or other provisions of this Agreement.

XIX. INTENTIONALLY DELETED

This Agreement may be executed in two or more counterparts, either in electronic or nonelectronic form, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. If a party sends a signed copy of this Agreement via electronic means, such party, will upon request by the other party, provide an original handwritten signed copy of this Agreement. A printed version of the electronic form or counterpart of this Agreement will be admissible in judicial proceedings based upon or relating to this Agreement to the same extent and subject to the same conditions as other documents originally generated and maintained in printed form

XXII. NOTICES

Except as otherwise provided by this Section, notices, consents, approvals, demands, requests or other communications provided or permitted under this Agreement, will be in writing and sent via certified mail, hand delivery, overnight courier, facsimile transmission (to the extent a facsimile number is set forth below), or email (to the extent an email address is set forth below) as provided below, and notice will be deemed given (i) if delivered by certified mailed, when deposited, postage prepaid, in the United States mail, or (ii) if delivered by hand, overnight courier, facsimile (to the extent a facsimile number is set forth below) or email (to the extent an email address is set forth below), when received:

ADDENDUM TO AGREEMENT

The following terms and conditions are incorporated into and form a part of the agreement to which they are attached (Agreement) for all purposes. **University** and **UT System Institutions** have the same meaning as those terms are defined in the Agreement, and **Contractor** means SAGE Publications, Inc.

Representations and Warranties by Contractor. Contractor represents and warrants Contractor is duly organized, validly existing and in good standing under the laws of the state of its organization; it is duly authorized and in good standing to conduct business in the State of Texas; it has all necessary power and has received all necessary approvals to execute and deliver this Agreement; and the individual executing this Agreement on behalf of Contractor has been duly authorized to act for and bind Contractor.

Tax Certification. If Contractor is a taxable entity as defined by [Chapter 171, Texas Tax Code](#), then Contractor certifies it is not currently delinquent in the payment of any taxes due under Chapter 171, Contractor is exempt from the payment of those taxes, or Contractor is an out of state taxable entity that is not subject to those taxes, whichever is applicable.

Payments. So long as Contractor has provided University with its current and accurate Federal Tax Identification Number in writing, University will pay Contractor for goods and services in accordance with [Chapter 2251, Texas Government Code](#). University (a state agency) is exempt from Texas Sales & Use Tax on goods and services in accordance with [§151.309, Texas Tax Code](#), and [Title 34 Texas Administrative Code \(TAC\) §3.322](#).

Payments by Electronic Funds Transfer. [§51.012, Texas Education Code](#), authorizes University to make payments through electronic funds transfer methods. Contractor agrees to accept payments from University through those methods, including the automated clearing house system (ACH). Contractor agrees to provide Contractor's banking information to University in writing on Contractor letterhead signed by an authorized representative of Contractor. Prior to the first payment, University will confirm Contractor's banking information. Changes to Contractor's bank information must be communicated to University in writing at least thirty (30) days before the effective date of the change and must include an IRS Form W-9 signed by an authorized representative of Contractor.

Payment of Debt or Delinquency to the State. Pursuant to [§§2107.008](#) and [2252.903, Texas Government Code](#), Contractor agrees any payments owing to Contractor under this Agreement may be applied directly toward any debt or delinquency Contractor owes the

State of Texas or any agency of the State of Texas, regardless of when it arises, until paid in full.

Texas Family Code Child Support Certification. Pursuant to [§231.006, Texas Family Code](#), Contractor certifies it is not ineligible to receive the award of or payments under this Agreement, and acknowledges this Agreement may be terminated and payment withheld if this certification is inaccurate.

Access by Individuals with Disabilities. Contractor represents and warrants (EIR Accessibility Warranty) the electronic and information resources and all associated information, documentation, and support Contractor provides to University under this Agreement (EIRs) comply with applicable requirements in [1 TAC Chapter 213](#) and [1 TAC §206.70](#) (ref. [Subchapter M, Chapter 2054, Texas Government Code](#)). To the extent Contractor becomes aware the EIRs, or any portion thereof, do not comply with the EIR Accessibility Warranty, then Contractor represents and warrants it will, at no cost to University, either (1) perform all necessary remediation to make the EIRs satisfy the EIR Accessibility Warranty or (2) replace the EIRs with new EIRs that satisfy the EIR Accessibility Warranty. If Contractor fails or is unable to do so, University may terminate this Agreement and, within thirty (30) days after termination, Contractor will refund to University all amounts University paid under this Agreement. Contractor will provide all assistance and cooperation necessary for performance of accessibility testing conducted by University or University's third party testing resources, as required by [1 TAC §213.38\(g\)](#).

Venue; Governing Law. Travis County, Texas, will be the proper place of venue for suit on or in respect of this Agreement. This Agreement, all of its terms and conditions and all of the rights and obligations of its parties, will be construed, interpreted and applied in accordance with, governed by and enforced under, the laws of the State of Texas.

Breach of Contract Claims. To the extent that [Chapter 2260, Texas Government Code](#), is applicable to this Agreement and is not preempted by other applicable law, the dispute resolution process provided for in Chapter 2260 and the related rules adopted by the Texas Attorney General pursuant to Chapter 2260, will be used by University and Contractor to attempt to resolve any claim for breach of contract made by Contractor that cannot be resolved in the ordinary course of business. The chief business officer of University will examine Contractor's claim and any counterclaim and negotiate with Contractor in an effort to resolve the claims. The parties specifically agree (i) neither execution of this Agreement by University nor any other conduct, action or inaction of any representative of University relating to this Agreement constitutes or is intended to constitute a waiver of University's or the state's sovereign immunity to suit; and (ii) University has not waived its right to seek redress in the courts.

Entire Agreement; Modifications. This Agreement supersedes all prior agreements, written or oral, between Contractor and University and will constitute the entire Agreement and understanding between the parties with respect to its subject matter. This Agreement and each of its provisions will be binding upon the parties, and may not be waived, modified, amended or altered, except by a writing signed by University and Contractor.

Loss of Funding. Performance by University and each UT System Institution under this Agreement may be dependent upon the appropriation and allotment of funds by the Texas State Legislature (**Legislature**) and/or allocation of funds by the Board of Regents of The University of Texas System (**Board**). If Legislature fails to appropriate or allot necessary funds, or Board fails to allocate necessary funds, then (1) the University will issue written notice to Contractor and University may terminate this Agreement without further duty or obligation or (2) the University will issue written notice to Contractor that one or more UT System Institutions are affected by such failure and the University may terminate the further duty or obligation (provided, however, that this Agreement will not terminate with respect to any UT System Institutions not affected by such failure, but the University and Contractor shall amend this Agreement to reduce the amounts invoiced by Contractor on and after the date of such termination in order to reflect the termination of such UT System Institutions.) Contractor acknowledges that appropriation, allotment, and allocation of funds are beyond University's and any UT System Institution's control.

State Auditor's Office. Contractor understands acceptance of funds under this Agreement constitutes acceptance of authority of the Texas State Auditor's Office or any successor agency (Auditor), to conduct an audit or investigation in connection with those funds (ref. [§§51.9335\(c\)](#), [73.115\(c\)](#) and [74.008\(c\)](#), Texas Education Code). Contractor agrees to cooperate with Auditor in the conduct of the audit or investigation, including providing all records requested. Contractor will include this provision in all contracts with permitted subcontractors.

Limitations. THE PARTIES ARE AWARE THERE ARE CONSTITUTIONAL AND STATUTORY LIMITATIONS (**LIMITATIONS**) ON THE AUTHORITY OF UNIVERSITY (A STATE AGENCY) TO ENTER INTO CERTAIN TERMS AND CONDITIONS THAT MAY BE PART OF THIS AGREEMENT, INCLUDING TERMS AND CONDITIONS RELATING TO LIENS ON UNIVERSITY'S PROPERTY; DISCLAIMERS AND LIMITATIONS OF WARRANTIES; DISCLAIMERS AND LIMITATIONS OF LIABILITY FOR DAMAGES; WAIVERS, DISCLAIMERS AND LIMITATIONS OF LEGAL RIGHTS, REMEDIES, REQUIREMENTS AND PROCESSES; LIMITATIONS OF PERIODS TO BRING LEGAL ACTION; GRANTING CONTROL OF LITIGATION OR SETTLEMENT TO ANOTHER PARTY; LIABILITY FOR ACTS OR OMISSIONS OF THIRD PARTIES; PAYMENT OF ATTORNEYS' FEES; DISPUTE RESOLUTION; INDEMNITIES; AND

CONFIDENTIALITY, AND TERMS AND CONDITIONS RELATED TO LIMITATIONS WILL NOT BE BINDING ON UNIVERSITY EXCEPT TO THE EXTENT AUTHORIZED BY THE LAWS AND CONSTITUTION OF THE STATE OF TEXAS.

Ethics Matters; No Financial Interest. Contractor and its employees, agents, representatives and subcontractors have read and understand University's Conflicts of Interest Policy at <http://www.utsystem.edu/board-of-regents/policy-library/policies/int180-conflicts-interest-conflicts-commitment-and-outside->, University's Standards of Conduct Guide at <http://www.utsystem.edu/sites/utsfiles/documents/policies-rules/ut-system-administration-standards-conduct-guide/ut-system-administration-standards-conduct-guide.pdf>, and applicable state ethics laws and rules at <http://www.utsystem.edu/offices/general-counsel/ethics>. Neither Contractor nor its employees, agents, representatives or subcontractors will assist or cause University employees to violate University's Conflicts of Interest Policy, University's Standards of Conduct Guide, or applicable state ethics laws or rules. Contractor represents and warrants that no member of the Board has a direct or indirect financial interest in the transaction that is the subject of this Agreement.

Further, Contractor agrees to comply with [§2252.908, Texas Government Code \(Disclosure of Interested Parties Statute\)](#), and [1 TAC §§46.1 through 46.5 \(Disclosure of Interested Parties Regulations\)](#), as implemented by the Texas Ethics Commission (TEC), including, among other things, providing the TEC and University with information required on the form promulgated by TEC. Proposers may learn more about these disclosure requirements, including the use of TEC's electronic filing system, by reviewing the information on TEC's website at https://www.ethics.state.tx.us/whatsnew/FAQ_Form1295.html.

Public Information. University strictly adheres to all statutes, court decisions and the opinions of the Texas Attorney General with respect to disclosure of public information under the *Texas Public Information Act (TPIA)*, [Chapter 552, Texas Government Code](#). In accordance with [§§552.002](#) and [2252.907, Texas Government Code](#), and at no additional charge to University, Contractor will make any information created or exchanged with University pursuant to this Agreement (and not otherwise exempt from disclosure under TPIA) available in a format reasonably requested by University that is accessible by the public.

Subcontracting. Contractor will use good faith efforts to subcontract work performed under this Agreement in accordance with the Historically Underutilized Business Subcontracting Plan (HSP) (ref. [Exhibit 4](#)) Except as specifically provided in the HSP, Contractor will not subcontract any of its duties or obligations under this Agreement, in whole or in part. This Agreement is subject to [34 TAC §20.285](#). Contractor will comply

with all of its duties and obligations under [34 TAC §20.285](#). In addition to other rights and remedies, University may exercise all rights and remedies authorized by [34 TAC §20.285](#).

External Terms. This Agreement completely supplants, replaces, and overrides all other terms and conditions or agreements, written or oral, concerning Contractor's performance or provision of goods or services under this Agreement (External Terms). External Terms are null and void and will have no effect under this Agreement, even if University or its employees, contractors, or agents express assent or agreement to External Terms. External Terms include any shrinkwrap, clickwrap, browsewrap, web-based terms and conditions of use, and any other terms and conditions displayed in any format that University or its employees, contractors, or agents are required to accept or agree to before or in the course of accessing or using any goods or services provided by Contractor.

Addendum Controlling. If there is a conflict between the terms and conditions of the agreement to which this Addendum is attached and this Addendum, this Addendum controls.

* * *

No Joint and Several Liability. Without limiting the "Limitations" provision herein, the parties agree as follows:

1. The licenses granted to UTS and the UT System Institutions under this Agreement shall be separate and distinct from the licenses granted to HAM and the HAM Institutions under this Agreement. This Agreement is not a joint and several contract and the liabilities arising under this Agreement are not joint and several liabilities. UTS/the UT System Institutions and HAM/the HAM Institutions shall be severally, not jointly, liable for the performance of their respective duties and obligations under this Agreement (including, but not limited to, the payment of the Fees due under this Agreement) and the payment of any damages arising under this Agreement.
2. To the extent that this Agreement places a duty or obligation on the "Subscriber," UTS and the UT System Institutions shall only be obligated to perform such duty or obligation to the extent that such duty or obligation applies to their access or use of the Licensed Materials and HAM and the HAM Institutions shall only be obligated to perform such duty or obligation to the extent that such duty or obligation applies to their access or use of the Licensed Materials. UTS and the UT System Institutions shall not be required to make any payment or perform any

obligation due to the failure of HAM or the HAM Institutions to do so and HAM and the HAM Institutions shall not be required to make any payment or perform any obligation due to the failure of UTS or the UT System Institutions to do so. UTS is responsible for ensuring that the UT System Institutions are in compliance with the obligations set forth herein, and HAM is responsible for ensuring that the HAM Institutions are in compliance with the obligations set forth herein.

3. UTS and the UT System Institutions shall not be deemed to have breached or defaulted under this Agreement on account of any act or omission of HAM or a HAM Institution, regardless of whether such act or omission is known to UTS or the UT System Institutions, and HAM and the HAM Institutions shall not be deemed to have breached or defaulted under this Agreement on account of any act or omission of UTS or a UT System Institution, regardless of whether such act or omission of UTS or a UT System Institution is known to HAM or the HAM Institutions. Under no circumstance shall Contractor require UTS or the UT System Institutions to cure the breach or default of HAM or the HAM Institutions or require HAM or the HAM Institutions to cure the breach or default of UTS or the UT System Institutions.
4. Contractor's suspension or termination of this Agreement with respect to HAM shall only suspend or terminate this Agreement with respect to HAM and the HAM Institutions and shall have no impact on the rights of UTS or the UT System Institutions under this Agreement which shall continue in full force and effect. Contractor's suspension or termination of this Agreement with respect to UTS shall only suspend or terminate this Agreement with respect to UTS and the UT System Institutions and shall have no impact on the rights of HAM or the HAM Institutions under this Agreement which shall continue in full force and effect.

No Personal Liability. Notwithstanding any duty or obligation of University to Contractor or to anyone claiming through or under Contractor, no present or future partner or affiliate of University or any agent, officer, director, employee, or regent of University or anyone claiming under University has or shall have any personal liability to Contractor or to anyone claiming through or under Contractor by reason of the execution or performance of this Agreement.

Relationship of the Parties. For all purposes of this Agreement and notwithstanding any provision of this Agreement to the contrary, Contractor is an independent contractor and is not an employee, partner, joint venturer, representative or agent of University. Contractor will not bind nor attempt to bind University to any agreement or contract. As an independent contractor, Contractor is solely responsible for all taxes, withholdings, and other statutory or contractual obligations of any sort, including but not limited to workers' compensation insurance. Nothing in this Agreement shall be construed to make either UTS or HAM the employee, partner, joint venture, representative or agent of the other or to require either UTS or HAM to indemnify Contractor for any claim or loss of any nature caused in whole or in part by the other party.
